This Policy will set up a tentative schedule for the Title I events and activities to be held for the school year to carry out the policy.

TCMS Parents are asked to provide their opinion through meetings, events evaluations, and surveys to determine how effective the parent involvement activities have been. All unsatisfactory parent comments about the Title I School-wide Plan will be sent to the school district office of Federal Programs. Reasonable support for parental involvement activities as parents may request is based on the Title I Parent Involvement Survey results. Title I programs at Turner County Middle School, that involve parents, will be offered at varied times and days and will strive to eliminate the barriers that may prevent parent involvement. Turner County Middle School will provide opportunities for parents to make suggestions and participate in decisions relating to the education of their children. The school will respond to these suggestions as practicably as possible.

A Title I Annual Meeting for Turner County Middle School is held each year. The meeting is scheduled in the fall when it is most convenient for the majority of parents to attend. All parents are invited and encouraged to attend. During this meeting, the Title I program will be explained. Staff will assist parents in understanding how Turner County Middle School is participating in Title I and how parents have the right to be involved in their child's education. Turner County Middle faculty and staff will provide handouts, letters, invitations, flyers and other written communication and other information sent home to parents in a language and format that is easy for all parents to understand. Communications listed below will be sent timely as required.

- the school performance profiles,
- the assessment (testing) results of their child, including alternate assessments such as the Georgia Alternate Assessment.
- how to interpret those results,
- a description and explanation of the curriculum (subjects) at Turner County Middle,
- Which assessments/tests are being used to show the progress of their child; including alternate assessments such as the Georgia Alternate Assessment.
- What are the scores or range of scores that their child(ren) are expected to meet
- Notifications of regular meetings to formulate suggestions and decisions relating to the education of their child, follow-up in response to the suggestions made by parents

Accommodations will be made available for parents with disabilities and/or Non- English speaking parents when needed. School related information will be sent to parents in a format to the extent practicable in a language that all parents can understand.

Turner County Middle School faculty and staff will work jointly with parents to develop a school-parent compact which will outline how parents, the entire school staff, and students will share responsibility for student academic achievement along with providing materials and training to help parents work with their children to improve their children's level of achievement and specific literacy-related training for parents. Turner County Middle School will offer a Parent Resource Center and offer information and programs to help parents learn about child development, child rearing issues and other parenting concerns designed to help parents become full partners in the education of their children. Parent involvement training for parents on how to access and use a variety of sources of technology on the computers will be provided.

Results of surveys, evaluations and meetings are used by parents and staff of Turner County Middle School to work together to ensure that all faculty and staff understand the following or are provided training regarding:
